Introductory note

This introductory note does not form a part of the notice

The following notice gives notice of the variation of an environmental permit.

This administrative variation is to add waste code 15 01 05 to the permit. This additional waste type does not change the nature of the activity or increase risk at the site, based on waste types already accepted and existing permit condition requirements.

The wording of some of the waste code descriptions in Table S2.1 has been amended to be in line with current standards, and some typographical errors in the table have been corrected.

The definition in the original permit for “hazardous waste” has been removed, and new definitions for “hazardous property”, “hazardous substance” and “hazardous waste” have been added, in line with current standards and to correspond with some of the amendments made to the wording of waste code descriptions.

There are no other changes to the permit.

The schedules specify the changes made to the original permit.
