Review of Q1 2019 (January - March 2019) monitoring data submitted by Befesa Salt Slags to satisfy reporting requirements of permit VP3030BX.

Emission point A1 monitored for particulate matter. Emission points A2,A5,A6 for Ammonia and A7 for Ammonia, Phosphine and Hydrogen Sulphide.

Noted that air emissions from A1,A2, A6 and A7 are below permitted emission limit values (ELV) from permit VP3030BX.

Higher ammonia levels from emission point A5 at 9.1 mg/m³, but noted that with measurement of uncertainty at 0.27mg/m³ that emissions likely to be below ELV of 9mg/m³.
