Schedule 5 Notification - HAF237 (26.06.2019)

A Schedule 5 Notification, reference HAF237 was received from the Operator on the 26th of July 2019. The notification was related to muddy surface water on a road outside the site entrance gates following an extremely high rainfall event, reported on the 18th of July 2019.

Following receipt of the complaint the Operator installed a cut off drain where the surface water was running down an internal clay slope prior to leaving the site at the site entrance gates. The cut off drain now diverts any run off into a lagoon where the surface water is collected and the silt dropped out, see photograph below:



Permit condition 3.3.1 states that there shall be no point source emissions to water, air or land except from the sources and emission points listed in schedule 3 tables S3.2, S3.3 and S3.4.

Although this incident is technically a breach of the above condition, we have decided not to apply a CCS score on this occasion, due to the unforeseeable nature of the extremely high rainfall event, and the prompt response undertaken by the Operator.

The Operator shall undertake all necessary precautions to ensure that this issue is not repeated at the site.
