This was a routine site inspection.

Weather conditions were overcast and ground conditions were damp underfoot.

Nobody was present at the site although neighbouring quarrying operations were taking place.

Inspecting officers undertook a brief walkover of the permitted area. The area is now grassed with vegetation (saplings) becoming well established.

No issues were observed whilst undertaking the walkover.

No run off from the site was observed during the inspection.

No amenity issues (noise, dust, pests, vermin) were observed throughout the inspection.

A recent enquiry regarding permit surrender was made to Natural Resources Wales from a consultant operating on behalf of the operator.

The consultant was advised that as indicated within the Compliance Assessment Report following the site inspection undertaken on the 29 March 2017 a litter pick was requested to take place. However, following this inspection I am satisfied that litter is no longer a concern and no further action is required at present.

In addition, the consultant was advised of the requirement under condition 2.1.5 of the site permit which states '*On completion of the reclamation, restoration or improvement work a survey of final waste levels relative to Ordnance Datum shall be submitted to Natural Resources Wales within one month*'. To date this has not been received. Please could this be forwarded to Natural Resources Wales (Via myself – Ross Briscoe) prior to permit surrender.

No other issues were noted whilst undertaking this inspection.
