No breaches of the site permit were identified during the inspection.

The drainage channels surrounding the site were dry during the time of inspection. Please ensure that drainage on site is maintained efficiently to restrict the escape of sediment from waste deposition areas into controlled waters.

Table 2.1 in the site's permit outlines that "in any case waste shall only be spread to a thickness not exceeding 2 metres". Please ensure that this permit condition is complied with. During the time of the inspection, waste was seen to be stored in quantities exceeding this height. The waste however was yet to be levelled, and I was reassured on site that the waste would be levelled out to comply with this condition.
