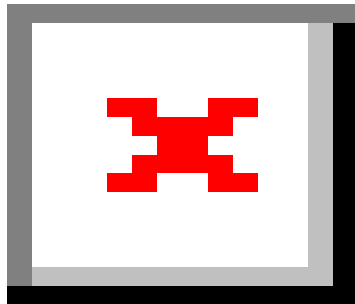

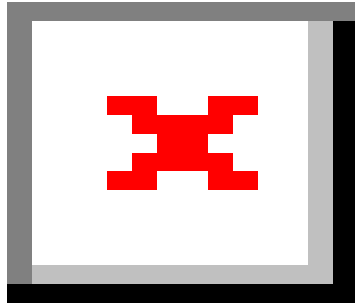

This inspection was organised by request of the operator in light of proposals to surrender the permit. The inspection was conducted by Environment Officers Leon Williams and David Wilby, accompanied by John Davies of Watkin Jones & Son Limited.

Waste deposition operations have now ceased at the site. Our records show that a total of 49,147 tonnes of waste have been deposited at the site. This figure is just shy of the 50,000 tonne limit permitted by the site permit.



The final capping of waste has been completed at the site and has since been seeded with grass seeds. A small quantity of contaminants was seen to be present on the capping, Mr Davies agreed to organise a litter pick to remove the visible contaminants from the site. Please ensure that the said waste is disposed of appropriately at a licensed waste facility.



Attention was drawn to permit condition 2.1.5 on site. This condition states that “on completion of the reclamation, restoration or improvement work a survey of final waste levels relative to Ordnance Datum shall be submitted to *Natural Resources Wales* within one month”. Upon receiving this report, NRW will confirm the type of surrender required to bring operations at Ty Mawr East to an official close.

No further concerns were identified during the inspection.
