This was an unannounced inspection following the recent refurbishments to site to a two-tier system, Regulating Officer Steve White was accompanied around site by site supervisor Glyn Hughes.

There were no issues observed on site during the inspection. The new two-tier layout seems to be working well with site operatives and members of the public both expressing satisfaction at the new layout.

Drainage on site was inspected and there was no litter observed, new compactors were being installed on site.

There were no issues with storage of materials on site, all relevant wastes were stored in the correct skips, the battery box was covered and asbestos skip was locked.

Site operatives were helpful and knowledgeable regarding the procedures for the site
