Hafod Quarry Landfill Site - Landfill Gas Management Plan (May 2019)

We have reviewed the above document with reference to LFTGN03, Guidance on the management of landfill gas. The plan covers many of the requirements of LFTGN03, however it is considered that the plan requires further information in the following areas:

- Monitoring and sampling plans (see section 3.3.3), including:

A description of the measurement techniques and sampling strategy;

A methodology for data storage, retrieval and presentation;

The methodology for data interpretation, review and reporting;

The means of communicating the results of the monitoring and interpretation to the regulator.

- Action plans (see section 3.3.4), including:

Actions to be taken by the operator as a result of:

Any abnormal changes observed in collected monitoring data;

All identified operational problems or failure of the gas control system established as part of the routine inspection or maintenance programme;

A reported event, e.g. an odour complaint;

A subsurface fire.

The plan should set out the procedures and protocols by which the operator will manage the effects these events.

Emergency procedures and protocols.

Remedial actions.

- Site-specific staff responsibilities for gas management (including competence and training).
- Reporting and notification to NRW – mention Permit conditions & Schedule 5 notification.
- The monitoring of landfill gas from capped surfaces.
- Table in 4.3 Flare Emissions Monitoring is missing Temperature (weekly).
- Table in 5.42 Inlet Trace Gas Analysis contains 25 compounds, not the full list of 29 compounds in LFTGN04.
- Methane compliance limits listed in Table S4.5 in section 3.8.4 are not the current permitted

limits. As previously agreed any changes to methane compliance limits should be submitted as part of a permit variation, which can then be reviewed by NRW.
