A routine site visit took place at the Greenfield site on the 27th March, 2015. The COTC was not available at the time of the visit.

The inspection took place at 8:10am whilst the CA site was closed, however the site was accessible. Operatives were all working in the composting area with shredding of green waste and screening of compost taking place. There were no odours detected external to the site.

On a previous visit issues were raised concerning water within the battery boxes. This had now been rectified and the boxes moved to an alternative area within the site. Thank you.
