A pre-arranged site visit took place on 4th April 2018. Present were the Regulating Officer Julie Hughes, Paul Challender, Ruth Cartwright TCM and Clare Docherty.

An updated copy of the environmental management system (EMS) had been submitted to NRW. Several minor amendments were required to finalise the document which were discussed on site.

The inspection covered the three areas of the site:

The CA site

Flintshire Council have introduced new opening hours for the public visiting the site

- 10am to 6pm - 1st April to 30th September
- 9am to 5pm - 1st October to 31st March

There were no issues observed on the CA site during the visit.

Composting site

The new shredder was in operation whilst the inspection was being carried out. There was a noticeable

improvement to the quality of the shredded material which will aid composting.

A new contract had been agreed with a horticulture company who will take all PAS 100 compost from the site reducing the need to stockpile.

There were no issues recorded regarding the composting operations on site.

Transfer Station

The transfer building was now operational with kerbside collections being brought onto site.

As previously discussed the site may now fall under the MF regulations. Documentation regarding the requirements were sent to the TCM on 6th June 2017. If you require me to re send the links within the email, please let me know.

On leaving the site it was noted that there was some wind-blown litter along the watercourse. Please ensure that this area is routinely checked, and a litter pick carried out as necessary.
