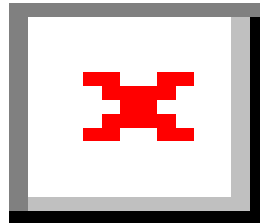
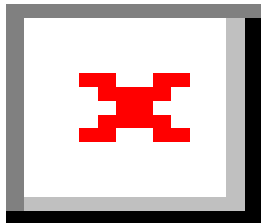

Site inspection was carried out by new Regulating Officer Steven White, Nick Davies accompanied me around site during the visit.

Waste Returns had been checked prior to the visit, 195T had been removed from site and only 4.4T accepted on site in 2017. Following discussions with Nick during the inspection advice and guidance has been given regarding the surrender of the site permit; as the site permit is a Standard Rules Set the cost for this surrender would be £3588.

There were no issues found during the inspection, there was some metals still left on site prior to removal (estimated at approx. 100T) and a small amount of plastics (see photos below)

Plastics are not one of the wastes listed in table S2.2 of the permit, these wastes will need removing from the permitted area of the site.

Permit condition 4.3.3 goes into detail about notification to NRW if a permitted site is being wound up; if you decide to surrender the permit you will need to inform us (in writing) of your intentions for the site.
