This was an unannounced routine site inspection. Met and accompanied by Arthur Imrie on site. Photos taken during the site inspection.

Initial observations were that there was more waste on site than has been observed on past site inspections. However, this is not an issue as the overall quantities allowed in the permit did not look to have been exceeded. In particular there was a relatively large amount of wood on site. It was explained that the site which usually takes the waste wood (TG Group, Ellesmere) had recently had a fire on site which had resulted in delays in sending waste wood out. Waste wood was now being sent out as normal.

There were some concerns raised regarding recent fires in the area. If the fires produce black smoke and come from a business premises then please report them to NRW via the 24 hour phone number 0300 065 3000. If we are not made aware of the burning then we are unlikely to be able to do much about it.
