Officers Alex BOWDER and David WARWICK-BROWN attended Forward Waste Management Ltd at 10:30 on Thursday 17th January 2019 to carry out a routine inspection of permit **EPR-AB3099FT**. The weather conditions were cold and dry at the time of visit. Met with Transport Manager Craig Housley and Health and Safety Manager Victor Garrick who accompanied Officers around the yard.

GENERAL OBSERVATIONS

The business is now utilising the new office unit in the yard. It was mentioned that the site has added electric-tagged gates which aids with the security of site.

No major changes to operations since the last inspection. The unit compacts and bails the different grades of cardboard/plastic which then are temporarily stored and transported to end destination customer/TFS.

Inspected the filter cake material storage - no issues apparent. Officers spoke about the 50 tonnes storage limit in the permit and whether vehicles in-transit contribute to this tonnage. It was apparent that operations had control of all tonnages of the material on site at any given time – Waste code **11 01 98/10**.

Discussed the management of the contaminated oil rags and destinations.

T11 EXEMPTION - Reference **EPR/GB3395HE**

Allows for the repair, refurbishment or dismantling of various types of WEEE (Waste Electrical and Electronic Equipment). No WEEE recovery activities were taking place in main unit although engineering repair works on parts are continuing in adjacent building.

INFRASTRUCTURE AND DRAINAGE

No issues apparent with facilities. All operations are carried out indoors and so no exposure to outside elements or contact with water.

Officers met with business Director Mr. Lyndon Ward, who discussed permitting another yard for similar waste transfer station operations in Cardiff. Spoke about the potential activities and the suitable environmental permits for the operations. We stated that the distance to protected areas, infrastructure and drainage system would need to be considered. This could require applying for a bespoke permit

option.

Waste Returns being submitted and filled out correctly. Site diaries are being completed on a daily basis by relevant personnel; various WAMITAB qualification holders within the business.

Good overall inspection with no breaches against permit conditions found.
