This Compliance Assessment Report form has been completed following the inspection of Swansea Drydocks.

The inspection confirmed that the facility is currently non-operational. The ownership of the company has changed but the company itself remains the operators of the permit.

Whilst the site is currently not operating, having not received any waste ships the facility infrastructure was checked and found to be in good order.

Works were being undertaken to repair the lock gates of the larger dry dock – the southern of the 2 dry docks. This means that currently this dock is flooded. The repair work is being undertaken within the remaining smaller dry dock.

Some repairs of ships have been undertaken in this remaining dry dock and so the repair work time schedule has had to be delayed somewhat.

There have been extensive repair works undertaken to the storage buildings on the northerly boundary of the site.

The impermeable pavement of the docks is showing slight wear but the permeability of the pad is not compromised.

Whilst on site discussions were held regarding the need for staff to be aware of the permit and operating procedures should ship dismantling commence. Follow up email discussions have confirmed that updated operating procedures are in place, and these have been shared with NRW and now kept on file.

Advice and guidance has been supplied regarding the requirements for a Technically Competent Manager (TCM) and WAMITAB certification advice forwarded.

If waste activities are to commence then a TCM needs to be in place/employed.

Advice was also forwarded regarding the pre-notification requirements if/when ships were purchased and confirmed to be coming for dismantling.

As the site was non-operational at the time of the visit no non-compliances with the permit were identified.
