The Mainport Ash Vessel completion statement was received on 27/01/2017, the document is dated September 2016 and a delay in reporting was agreed with the site regulatory officer.

Whilst annex 1- 4 was not received in the submission a separate compliance assessment has been undertaken on waste returns under NRW ref NRW0027033 and found to be in compliance.

Site inspection was undertaken during the recycling of the Mainport Ash vessel and documented under CAR ref NRW000046

Review of the completion statement submission has found it to be compliant with condition 2.3.1 table S1.2
