The visit to site was pre-arranged so that I could meet with Roger Price and Paul Reynard of P Dobbins and with Martin Womack of 4W Environmental Ltd. The purpose of the meeting was to discuss the bund that has been erected along the boundary of the site next to the railway line. This bund has been detailed in the previous two inspection forms for the visits dated the 30th July 2014 and the 5th November 2014.(Report IDs: 37160/0216574 and 37160/0225581). In both of these inspection forms the presence of this bund constructed from waste material has been regarded as a breach and will continue to be considered in this manner until the situation is resolved.

Breach

A1 - Permitted Activities - specified by permit - CAT3 - Permit Condition 2.1.1

As detailed above this breach is with regards to the use of unsuitable contaminated waste material to construct a bund along the edge of the site adjacent to the railway line. The deadline originally set by which we expected to see the bund removed and the contaminated waste disposed of appropriately was the 19th December 2014. This deadline has now passed and the breach is therefore considered a Cat 3.

During the meeting on site we discussed the options regarding this waste material used in the bund. It was recognised that the bunds had been constructed during a site clean up and that these bunds were intended to provide an additional barrier around the site to help prevent both any loose waste leaving site and any damage to perimeter fences from waste on site. I was asked if there was any way we could consider allowing this bund to remain in place as the cost to both remove and dispose of it at landfill is very high. I have therefore asked for a written summary providing details on the waste used to construct the bund (i.e. what is it and how much), how it would be disposed of and the associated costs. The summary should also provide details on any alternative suggestions they have for this material. I would expect to receive this report no later than the **1st May 2015**. Until a final plan of action is agreed we will have no other option than to continue scoring the breach on all future visits.

No other issues were observed during this site visit. On the whole the site was well organised and tidy.
