4. Details of our assessment

Abril Industrial Waxes

The Annual Reporting forms and Q4 monitoring returns, as required by permit conditions 4.1.2, were received on the 28th January 2022.

Quarterly report (Q4)

There were no emissions to air during this reporting period. The emissions to sewer were all reported within the permitted limits for this reporting period.

The data for Q4 has been accepted.

Annual Returns

Total Hazardous waste for 2021 was 2.352 tonnes which was a significant drop from 2020. Total non-hazardous waste for 2021 was 15.71 tonnes for 2021 which resulted in 6.710 tonnes of this waste being sent for recovery which is approximately 43%. These figures are fairly similar to 2020 with a total waste of 15.558 tonnes of which 7.558 tonnes were sent for recovery (49%). However, when comparing total waste to unit output there has been a continuing improvement since 2017.

Water usage

Water usage has increased by 15% when compared to 2020. However, when compared with the unit output, 2021 had the lowest ratio since 2017. This therefore suggests water efficiency is improving year on year.

Energy

Abril Waxes have continued to increase their energy supply from renewable sources. The report for 2021 shows an increase from 31% renewables to 68.8%. Primary energy has increased in 2021 compared to 2020, however when converted into CO₂ production, there is a reduction in 2021. This is due to an increase in the supplied energy being sourced from renewable energy sources. Finally the CO₂ produced per unit output has decreased in 2021.

Previous Actions

In the previous CAR Form (CAR_NRW0039001) Abril Waxes were asked to complete the improvements on the deteriorating rendering on the inside bund. Abril have since provided an update for this work which has highlighted a difficulty in obtaining suitable contractors. However, it is their intention to meet the deadline stated in the CAR Form or failing that to try to complete it as close to this date as possible. This has been accepted. Please keep NRW updated as this work progresses.
