This visit was not pre-arranged and carried out approximately 4 weeks after the previous visit on 14/11/2016 where it was indicated that a large proportion of the waste on site would have been removed by this date. When Officers Steven White and Ross Briscoe arrived it was clear that the site was closed for the Christmas period with no waste management activities being carried out on site.

The front gates were locked with wagons parked directly outside, and within, the compound to stop any access to the site. The damaged front gate and panel and the perimeter fencing had been fixed since the previous inspection leaving the site secure against any unauthorised access.

It was observed that there were no full skips stored outside the permitted boundary, the only skips outside were empty.
