Visit Report/Comments:

This was a routine site inspection carried out by Rachel Twiss and was not pre-arranged. The weather was dry and bright. Rhodri Roberts was not present upon my arrival, however a site operative was aware that I was there to conduct a site inspection and I proceeded. Rhodri arrived a short time afterwards & accompanied me throughout the inspection, photographs were taken.

Observations:

The site had more material present than during the last site inspection conducted in November 2015. Most waste streams were appropriately segregated and stored, however a large quantity of mixed waste was present at the rear of the yard which overflowed from the shed. The reason given for this was that the landfill used had been closed. The quantities exceeded the limits within the permit.

A substantial amount of wood was also still present which had been segregated. During this and the last inspection Rhodri was advised that any exemptions registered would override the site permit conditions relating to the same activity. Since looking into the guidance the S2 (storing waste in a secure place) exemption does not allow you to carry out the treatment of waste which includes sorting. One way of utilising an exemption would be to bring all waste into the permitted area for processing, then any resulting segregated wood could be moved over onto an exempt area for storage but this exempt area must be clearly segregated/separate from the permitted area. Exempt activities registered at Waste Operation sites automatically revoke the part of the permit that relates to that exempt activity. Before I left site Rhodri stated that he thought the area where wood was being stored was outside the permitted area after all. I requested a more recent site plan to outline this but have not yet received a copy. There is however, a version on our historic systems that appear to show that the permitted area does not cover the wood storage area. Please provide an up to date site plan for our records.

Two skips of waste were on the ground outside the permitted area, this issue was raised during the last inspection and yet skips containing waste are still situated outside the permitted area.

Breaches:

The following breach was observed during the site inspection:

C4 Management - Storage, Handling, Labelling and Segregation - CCS 3

The quantities of mixed waste and the duration it had been on site exceeded the limitations stated with section A:12 of your permit.

Skips containing waste were stored outside of the permitted area, this is a breach of condition A:9 which states that the site operations shall be conducted in accordance with the working plan. Section 1.3.1 of the working plan states the permitted area according to drawing no CS/2/1.

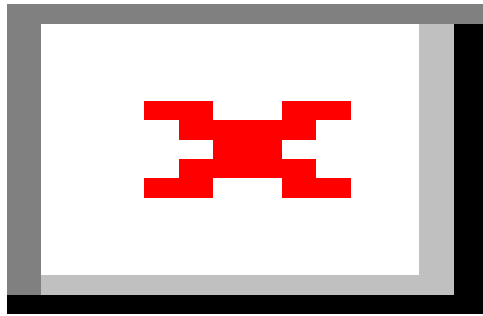
