Routine pre-announced inspection carried out by Environment Officer Rhys Thomas, accompanied by Environment Officer Llyr Thomas.

Officers first proceeded to the reception hall where a delivery of trade effluent had just been received. No food waste was stored in the reception hall at the time and this area was clean and tidy with good housekeeping practices observed.

Officers proceeded to the bunded yard outside, where the areas around the digester tanks, raw waste tank, pasteuriser and digestate storage tank were visually inspected. This area was tidy and organised and no leaks or spillages were visible from any of the tanks or pipework. Rainwater was collecting in the bunded area surrounding the digestate storage tank. The integrity of this bund appeared to be sound. The odour abatement systems were operational and no odour issues were noted during the visit.

Upon returning to the site office, the documentation for digestate removed off site were reviewed. These records were in good order.

Annual performance reports for 2017 were submitted in January as required. These included Air 1 Report, Energy Report and Environmental Report. No issues have been noted.

Quarterly waste returns for 2017 have been reviewed. All returns have been submitted as required.
