Waste Return Review

A review of your waste return submission has been carried out.

Unfortunately our records show that we have not received the waste Returns for Quarters 1 & 2 2016, Quarters 1, 2, 3, & 4 2015, Quarters 1, 2, and 4 2014. Condition 4.2.2 of your environmental permit requires waste returns to be submitted within 1 month of the end of each quarter. The breach of this condition has resulted in a CCS 4 score. Waste returns must always be submitted in accordance with condition 4.2.2 of your Standard Rules Permit even if they are a Nil return

The missing waste returns (Quarters 1 & 2 2016, Quarters 1, 2, 3, & 2015, Quarters 1, 2, and 4 2014) must be submitted to Natural Resources Wales by the 9th September 2016. Please also ensure that a system is put in place by the 9th September 2016 to prevent this breach from occurring again.
