2015 and 2016 Waste Return Review

A review of the 2015 and 2016 waste returns submissions for permit XB3597TM has been completed. Condition 4.2.2 of your permit requires that within one month of the end of each quarter a summary is to be submitted detailing all of the waste types and weights accepted on to site and leaving site. Unfortunately we have not received the waste returns for quarters 1, 2, 3, & 4 2015 and quarter 2 2016. This is a breach of your permit. As a direct result of this breach a CCS score 4 has been applied.

Please ensure that the missing waste returns for quarters 1, 2, 3, & 4 2015 and Quarter 2 2016 are submitted to waste.returns@cyfoethnaturiolcymru.gov.uk no later than the 31st October 2016. You must also ensure that a management system is put in place no later than the 31st October 2016 to prevent this breach from occurring again in the future.

Could I also take this opportunity to remind you that your waste returns for Q3 2016 are due to be submitted no later than the 31st October 2016. A copy of the waste return template has been attached for your use. Please ensure that you use your EPR number (XB3597TM) and not your EAWML number on the form and that in box 2.2 you need to enter your site type as A13: Household Waste Amenity Site.
