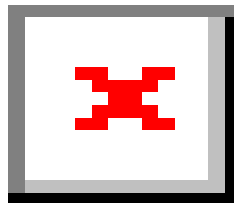
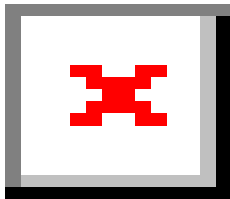
This was an unannounced inspection by Regulating Officer Steven White who was accompanied around site by John Evans.

Site was clean and tidy and well managed, there were CCTV cameras covering the site and the perimeter was checked and secure.

Waste is brought into site by the public and put into small skips, the wastes are then transferred to larger skips to be removed off site. The public are not allowed in the area where the larger skips are stored and filled.

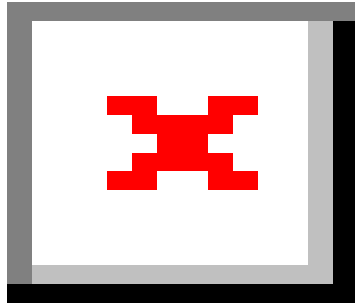
The skips were checked - there were no issues with contamination from other wastes in these skips. Site operatives were questioned on the processes and operations to ensure that the relevant procedures were carried out on site; site workers were helpful and knowledgeable with regards to the site and its operations.

There was little plasterboard in the relevant skip, asbestos is not accepted on site, mattresses were stored separately in a container. Batteries, paints, oils and household chemicals are all stored in sealed containers and on relevant bund-storage. (see photo below), There is plenty of spill kits available on site.

There was a separate container which stored furniture that was able to be re-used; this was sent to a depot in Flint for re-sale to the public, there is also a bay where compost (from Greenfield CA site) is sold to the public. (see photo below)
