Waste Returns - 2014, 2015 and 2016

Condition 4.2.2 of your permit (EPR/AB3433DY) requires you to submit your waste returns within one month of the end of each quarter. Unfortunately, despite the requirements of CAR Form dated 13th July 2015, Natural Resources Wales have not received your waste returns for quarters 3 and 4 2014, quarter 1 2015 as requested. Nor have Natural Resources Wales received the subsequent waste returns for quarters 2, 3, and 4 2015 or quarters 1 and 2 2016. As a direct result of this continued non-compliance with your permit a CCS score 4 has been applied against permit condition 4.2.2. Waste Returns should always be submitted even if it is a nil return.

In the CAR Form dated 13th July 2015 you were also required to ensure that a system was put in place to ensure that the breach against condition 4.2.2 from occurring again. As a direct result of failing to implement an adequate management system to prevent this breach reoccurring a result a CCS score 4 has been also been applied against condition 1.1 of your permit.

Please ensure that the waste returns listed below are submitted to waste.returns@cyfoethnaturiolcymru.gov.uk no later than the 2nd September 2016 and ensure a system is also put in place by this date (02/09/16) to ensure that these non-compliances with your permit will not occur again.
