Routine site inspection conducted by Environment Officer Leon Williams accompanied by Operator Meurig Jones. The weather during the time of the inspection was dry and sunny.

A new picking line has recently been installed at the site. Work had begun to re-arrange the rear of the site in order to create more space for the new system to be operated efficiently. Please ensure that no waste is deposited outside of the sites permitted boundary when this work is undertaken.

Discussions were held in relation to the magnetic conveyor used to process Gwynedd Council's recyclable waste. The operation of this system has been reviewed and is believed to be operated in compliance with condition A2, Table S1.1 activities, in the site's permit.

Quantities of plasterboard had been significantly reduced since the previous inspection at the site.

A collection of waste transfer notes were inspected on site, no issues were identified.

The site daily checklist was inspected, the document had been duly completed.

Section 1.4.4 of the site's working plan outlines that "the maximum amount of waste to be stored on site at any time will be 100 tonnes". The quantity of waste seen stored on site during the inspection was significantly higher than this limit. A CCS Category 4 breach has been recorded against this non-compliance. Please amend Section 1.4.4 of the working plan accordingly to outline a representative limit of waste storage procedures currently in place at the site.
