A site visit took place on Thursday 4th May, 2017. Weather at the time was dry and windy.

The Regulating Officer was accompanied on the visit by the site owner/Operator Mr Meurig Jones.

The visit commenced with a walk around site with Mr Jones explaining the operations which include:

- segregating clean wood before chipping and using in the sites biomass boiler. The boiler feeds the house, offices and buildings and is operated under an exemption.
- Sorting of mixed skip waste by hand
- Mechanical sorting of plastics and cans
- Mechanical sorting of C & D Waste
- Screening and crushing of inert waste to produce a WRAP quality protocol aggregates
- Site is accepting recylates from Gwynedd Council from householders and CA sites

Environmental Management System had been requested for submission to NRW by the 31st March, 2017. This request had not been complied with due to the unavailability of the consultant. Mr Jones had been in contact with the consultant and was due to discuss the EMS on Monday, 8th May, 2017.

Update received on 8th May indicated that the Operator would be meeting with the consultant on Wednesday 10th May to discuss the draft EMS with a copy of the EMS available on the 19th May, 2017.

Since the visit the EMS has been submitted to NRW – Thank you.

Advice was provided regarding the WRAP quality protocol regarding record keeping. Any material leaving site under the WRAP aggregates protocol should not be recorded on the quarterly waste returns as this material is no longer classed as waste.

Discussions took place regarding the possible need for testing of co-mingled waste which is brought onto site from the Local Authority. If the quantity is less than 1000 tonnes per year, there will be no need to carry out any testing. Figures on quantities to be submitted to NRW.

Following the visit the Operator provided the following figures: metal/aluminium cans 129.11 tonnes and plastic 354.48 tonnes per year. Testing will not be required at this time.

No permit breaches were recorded during this visit.
