4. Details of our assessment

On 21 January 2022, Natural Resources Wales received reports that a large plume of

smoke had been visible coming from the AMG site.

On contacting Adrian Stewart (TCM), an explanation was provided that:

“The ‘smoke plume’ was accidentally caused by our flame torch burners cutting up recently delivered demolition scrap and rail.

There was a small element of rubber attached to the plate & girder, which should have been eliminated immediately.

Due to the severity of the frost and cold weather that morning, our water bowser / hose was temporarily frozen. Therefore it took us slightly longer than anticipated to put out the ‘plume’.”

We understand that accidents such as this do happen on occasion, but where the measures on site, such as the bowser and hose were frozen, you must notify NRW without delay as stated in Condition 4.3.1 of your permit.

“4.3.1 Natural Resources Wales shall be notified without delay following the detection of:

(a) any malfunction, breakdown or failure of equipment or techniques, accident or emission of a substance not controlled by an emission limit which has caused, is causing or may cause significant pollution;”

Therefore, you have been scored a Category 3 breach of Permit Condition 4.3.1.

You must ensure you report any futures issues to NRW without delay.
