4. Details of our assessment

A routine site inspection was undertaken on Friday 21st January 2022. The main site inspection is covered by CAR form CAR_NRW0039243.

This Compliance Assessment report is focused on the site compliance with the Materials Recycling Regulations as this site is a notified Materials Recycling Facility.

Present at the time of the inspection were: David Morgan (Natural Resources Wales) Sally Wakeford (Natural Resources of Wales) and Chris Fender (City and County of Swansea).

The following observations were made:

The baled cans on site, appeared consistent with the high percentages recorded within your Q4 2021 waste returns.

The sampling area was still intact, was clean and tidy, with relevant weighing scales present. It was not discussed if these had been calibrated recently. Although the area was used for storage of other wastes, this did not interfere with the sampling area, nor would it contaminate samples. The sample waiting to be sorted was typical compared to the sampling inputs declared on the waste returns.

The waste sorting area was also well managed.

One anomaly was noted on the waste returns. Where the incoming mixed glass and metal go through a mechanised sorting process, these wastes should leave the site as a 19 12 code rather than the 15 01 04 and 20 01 02 codes.

The sampling reported on the Q4 2021 waste returns was suitable for the tonnage of imported and exported wastes, correct average weight and all fractions accounted for (i.e. they all add up to 100%).

No non-compliances were noted at the time of the inspection.
