General Management

During the inspection, general management of the site was good with the yard clear and tidy, with no litter or loose waste on site.

Under **condition 1.1.3** of the permit, *'Any person having duties that are or may be affected by the matters set out in this permit shall have convenient access to a copy of it at or near the place where those duties are carried out'*. During the inspection the permit was not able to be found in the office, you have not been scored for it on this occasion however, please ensure that in future, the required paperwork is available to all staff who may require it.

Acceptance and Storage of Wastes

All wastes were stored appropriately during the inspection in line with **Schedule 1** of the permit, all on impermeable surface with sealed drainage system.

Infrastructure

Infrastructure was in good condition during the inspection, impermeable surfaces were in good condition and drainage channels were kept clear from debris.

Previous inspection carried out **18/04/2017** it was recommended that the drainage plan is updated as it was established that the drainage system led to surface waters and not to fowl. Please confirm if this has been completed.
