There have been some staff changes at GD Environmental and during this visit I was introduced to their new compliance team; Fiona Lynass and Christina Lloyd. Ian Lynass (SEO) and Lee Anson (site Manager) were also present.

I was notified that there had been a change with the Certificate of Technical Competence (COTC) holder and TCM. Ian Lynass would be the named COTC holder or TCM for the site. A copy of his WAMITAB COTC was sent to me on the 6/6/2016.

A walk around the site had showed that there had been infrastructure improvements and large sections of the yard had been resurfaced. Mr Lynass confirmed this was part of an ongoing improvement plan and more resurfacing would take place.

There was good segregation of waste types and the yard area, waste storage and treatment shed were well organised and well managed.

The stock piles of wood and trommel had been significantly reduced since my last visit.

The stockpile of plaster board was starting to extend out of its storage bay but Mr Lynass explained that it was due to be removed from site.

No non compliances or permit breaches were recorded for this visit.
