4. Details of our assessment

Compliance assessment 25 June – 31 December 2021

Lubrizol (Warwick) - Fire in Granulation Plant 2

At 20:30 on 29 July 2021 a fire occurred in Granulation Plant 2. A break glass alarm was activated by a shift operator and the site emergency response team attended within 4 minutes. The flame detection system also activated the site alarm. The Fire Rescue Service (FRS) was called in.

The explosion suppression system performed as per design and the fluid bed dryer was extinguished immediately and the sprinkler system quickly put out the fire in the sieve decks and bucket elevator.

The emergency response team doused equipment and FRS undertook a thermal imaging camera survey and declared the incident over. No injuries were sustained by the emergency response team or FRS. Little water was used and contained in the plant drainage system. The overall environmental impact was minimal to surface water and air (smoke minimised by the sprinkler system). The plant was shut down and no electrical faults were identified.

The cause of the incident is believed to be due to a tetraacetylenediamine (TAED) blockage in a rotary valve and build up in the product oversize mill above it running @3,000 rpm and overheating. This ignited the dust / air mixture producing a flash fire in the sieve decks and bucket elevator, which propagated a dust explosion in the fluid bed dryer.

The incident has been investigated (fault tree analysis managed by ABB) and modifications to plant and equipment have been made including temperature measurement, level and rotation detection and maintenance and cleaning schedules. An alternative rotary valve was used in the rebuild and a replacement ordered. A weekly cleaning and inspection program is in place for the rotary valve and mill and will be replicated in Granulation Plant 3.

The incident is considered a breach of Permit Condition 2.3 Management with respect to maintenance and cleaning schedules and a non-compliance score of CCS 3 is considered appropriate. Actions completed.

Condition 2.3 Management, 2.3.5 All plant and equipment used in operating the Permitted Installation, the failure of which could lead to an adverse impact on the environment, shall be maintained in good operating condition.
