4. Details of our assessment

Forms R1, Waste Disposal and Recovery 2021; WU1, Water Usage 2021; E1, Energy Usage 2021 and PI1, Performance Indicators 2021 were received on 28th January 2022. Forms A1, Emissions to Air, 1st January - 31st December 2021 and W1, Emissions to Water, 1st January - 31st December 2021, were received on 31st January 2022.

All the reports are accepted.

W1, Emissions to Water 2021

The annual reporting of emissions to water is a new requirement resulting from the permit variation following the BRef review.

All parameters were within their respective emission limit values (ELV).

Air 1, Emissions to Air 2021

The annual reporting of particulate emissions to air is also a new permit requirement, effective from June 2020, after the BRef review of the permit.

A continuous emissions monitor is fitted to emission point A2. Particulate emissions from all the emission points were less than the ELV.

R1, Waste Disposal and Recovery 2021

Total waste generated in 2021 was higher than in 2020 and about the same per tonne of production (ptp). The amount sent for disposal was less than in 2020 and about 50% less ptp, with 10% more ptp being sent for recycling.

Total hazardous waste generated in 2021 was more than in 2020 and about 4% higher ptp. The amount sent for disposal was almost 50% lower ptp than in 2020 and the amount sent for recovery increased by almost 15% ptp.

Total non-hazardous waste generated in 2021 was less than in 2020 and was more than 25% less ptp. Waste sent for disposal was nearly a sixth ptp of the amount sent in 2020. The amount sent for recycling decreased by almost 25% ptp.

WU1 Water Usage 2021

The total amount of water used was more than in 2020, increasing by more than 35% ptp.

E1 Energy Usage 2021

The total amount of energy used in 2021 and the resulting CO₂ were more than in 2020 and slightly less ptp.

Performance Indicators 2021

The performance indicators for energy, waste and water are discussed above.

Production increased by almost 20% in 2020.

The total mass releases of lead were much lower in 2021, being more than half ptp than in 2020.

This has been another difficult year for manufacturing industry, but it is reassuring to see the increase in production volumes for 2021. Higher production volumes have improved some performance figures. It would be interesting to see the reason for the significant reduction in mass releases of lead, a very positive result which Natural Resources Wales hope will continue into 2022. The continuing improvement in some aspects of waste management is encouraging and shows an awareness of the efficient use of resources.
