All results for emission points A3, A4, A5, A6 and A7 are below the emission limit values set in the permit.

Schedule 5 Notification

Part A notification was received on the 01/12/2021 advising that:

a notification has been received from Environmental Health Officer on the 29th November 2021 with no date or time specified advising that there is a reported whining or squeaking coming from the site in the evening.

QC & Compliance Manager confirmed that the QC & Compliance Team carry out daily monitoring between 8:30 and 17:00 on a daily basis and no issues have been identified.

The maintenance team and mill operators have been notified of the complaint and will continue to monitor for noise and carry out timely maintenance to prevent noise on all shifts.

It would be useful for any dates and times of noise occurrence to be reported to us so that we can identify any specific issues.

Part B notification was received on the 23/12/2021 advising that:

a noisy bearing was identified on the conveyor from the external wheat silo. this was due to the remote greaser failing. A cherry picker was hired to gain access to the bearing. The remote greaser was repaired on the 16th December. Routine visual inspection of the greaser will be carried out to minimise the risk of reoccurrence.

Due to the initial report been anonymous and no specific date or time given, it is not possible to substantiate whether this 'noisy bearing' was the culprit of the noise report. Please continue to carry out daily inspections and regular maintenance so any issues are noted and fixed in a timely manner.
