This Compliance Assessment Report is in relation to a site inspection carried out on the 9th

December 2021. Due to Covid-19 restrictions and the Operators internal policies it was a external inspection of the site only.

Assessed amenity issues (noise, dust and road deposits) and none were noted during the time of the inspection.

Assessed containment of stored materials and bunded areas - all appeared satisfactory and no issues noted.

No other issues noted on site in relation to permit non-compliance.

Discussed the Part A received on the 01/12/21 and the subsequent investigation. Part B was sent in to NRW on the 23/12/21 (see CAR NRW0039266)
