4. Details of our assessment

The site sent the 2021 annual stack emissions test report for the CHP on the 29/12/2021.

The monitoring results are within the limits outlined in the permit and are compliant. The result for Total VOCs was 1109, above the permitted limit of 1000. However, this is within the permitted uncertainty limits outlined in the Guidance for monitoring landfill gas engine emissions, LFTGN08 v2 and the sites permit. The uncertainty for Total volatile organic compounds is 40% where method BS EN12619 is used.

The high Total VOC's recorded is a sign that engine may need maintenance and the site has informed NRW that the engine will have a overhaul in 2022.
