On 11th July 2017, a site inspection was conducted at Tondu by Ffion Thomas and accompanied by Laura Phillips.

A meeting was held with Mark Kirk Kier Contract Manager and Adam Neill Area Supervisor to discuss Sally's previous actions had been dealt with.

Mark Kirk to confirm that drainage is going to foul not surface. Also, to provide and confirm the drainage plan for the site (including confirmation of drainage connections for external food/can/plastic waste storage areas).

The following information was requested:

A copy of the current up to date EMS.

Confirm when engineering works are to be undertaken and if any drainage connections to foul are to be undertaken.

Adam to provide copies of internal engineering plans showing waste storage and treatment layout.

The above actions have a 1 week time frame, unless agreed otherwise in writing.

Whilst on site seagulls were noticed flying around site, advised that the food storage building is covered and managed.

A site Inspection was carried out and during which the following breaches were identified. 2.3-2.31 -Table 2.3(b) All waste shall be stored in a building or within a secure container.

Food storage building was found to be leaking.

This compliance breach has been scored as a Cat 3 under the CCS guidance.

Summary

Adam to forward details of actions taken to prevent further leakage and pollution mitigation eg; dialogue with haulier for replacement, evidence of procedural integrity checks undertaken to ensure sealed building.

Confirmation of drainage connection against the site drainage plans, survey.
