### **EPR/SP3936TL – Cenin Limited**

Cenin submitted their annual reporting to Natural Resources Wales (NRW) on the 19<sup>th</sup> January 2022.

#### **Air Emissions**

Cenin are required to submit results from emission point A1 which is for the Particulate Matter parameter. The results show that 4mg/m<sup>3</sup> is the highest figure read throughout the year. This is well within the permitted limit of 10mg/m<sup>3</sup>. This is compliant with the permit.

#### **Performance 1 Form**

Cenin submitted the performance form which relates to Table S4.3 in their permit. No hazardous waste was produced in 2021.

No blast furnace slag was produced in 2021.
