4. Details of our assessment

Annual and Q4 Monitoring returns submissions for 2021

Emissions to water data for Q4 2021 (October - December 2021) reviewed. Emissions from W1 tested for Flow, pH, Suspended Solids, COD, Iron, Chromium, Mercury, Nickel, Zinc. Noted that all measured parameters are below permitted emission limit values (ELV).

Emissions to Air

Combustion Plant

Combustion plant - gas firing, stacks A1, A2, A3, A4 NOT OPERATED, so no results. A5, A6, A7 and A8 monitored for NO_x and CO, all emissions below ELV's.

Galv Line

Galvanising Furnace no. 6, stack A35 monitored for NO_x and CO, no issues with reported data.

VOC Thermal Oxidisers

RTO's stacks A12, A12a, A21, A18 (COBRA) monitored for NO_x, CO and VOC, all below respective emission limit values for VOC.

Fugitive Emissions

Fugitive solvent emissions calculated for colour coat lines 2 and 1 with average emissions of 0.42% and 2.06% respectively. Fugitive solvent emissions in compliance with the requirements of Industrial Emissions Directive.

Annual Water & Energy Usage, Waste Disposal & Recovery

Annual Energy, water and waste data reported, no significant increases noted, no issues with data. Energy and Waste shows a recurring trend of reduction in comparison to 2019 figures and is akin to 2009 figures. Water has seen an increase in Non-Potable water use but significant reduction in potable use.
