Waste Return Review

A review of the waste returns for 2016 and quarters 1 and 2 2017 for permit number EPR-EB3390HL has been completed. 2. A management system must be implemented no later than the 14th October 2017 to prevent this breach of permit condition 4.2.3 from occurring again in the future/
