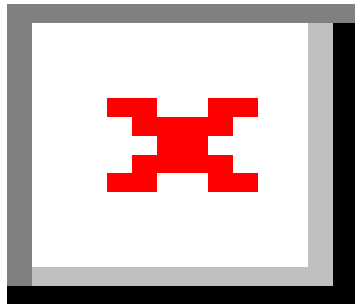
The report has been completed following an unannounced site inspection on 15th November 2017 by Ffion Thomas and accompanied by Laura Phillips.

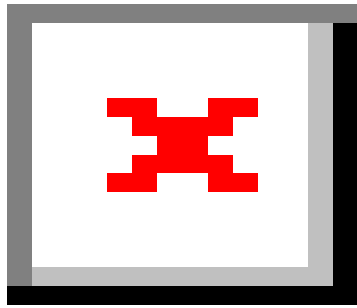
Whilst on site we witnessed waste being received on site. All the waste being received and stored was conforming to the permit. Externally we saw waste being loaded onto a skip. you are reminded that no waste is to be sorted on the ground externally.

The building was sound with no damage to the roof.

Our systems show the waste returns for 2016 and 2017 have not been submitted. A review of the last two CAR forms and our waste returns database show no records of waste returns being made. A non compliance against permit conditions 7.2.2 has been scored as a category 3 against criteria G4. If evidence is forwarded to demonstrate returns have been submitted then we will re-assess this score.

You enquired about pre-application advise and a meeting has been set for the 18th January 2018.
