

# **Natural Resources Wales permitting decisions**

## **Bespoke permit**

We have decided to grant the permit for Red House operated by Mr Russell Williams.

The application number is PAN-002857

The permit number is EPR/AB3998HL

The permit regulates the discharge of organophosphate sheep dip, diluted to a ratio of 1 part dip to 3.9 parts water/slurry, discharged to ground via a vacuum tanker. The maximum daily loading of diluted sheep dip should not exceed 10.3 cubic metres spread on a minimum of 0.52 hectares of land three times a year. Each dip shall be spread on different pieces of land, therefore the applicant will require a total of 1.55 hectares of land to spread the sheep dip. The discharge shall consist only of waste, sheep dip, derived from use at Red House.

We consider in reaching that decision we have taken into account all relevant considerations and legal requirements and that the permit will ensure that the appropriate level of environmental protection is provided.

## **Purpose of this document**

- shows how all relevant factors have been taken into account
- justifies the specific conditions in the permit other than those in our generic permit template.
