Following the issuing of the Permit a routine visit took place at the permitted site and at the main office.

The visit took place on the 15<sup>th</sup> June, 2017. Present were Regulating Officers Julie Hughes and Leon Williams and Nia Jones the site TCM.

Nia discussed the operations on site and how they would be dealing with the acceptance and treatment of the waste. There were no issues recorded at the site.

On moving to the main office in Penrhyndeudraeth we discussed all sections of the first visit check list. The information would be recorded and sent to Nia to sign, if agreed, and return to the regulating officer.

The EMS was incorporated into the business' ISO 14001. It was agreed that a site-specific EMS would be created and kept in the office with the permit for reference.

Nia Jones would be the site Technically Competent Manager. Nia had registered for the relevant WAMITAB course and was soon to meet up with her Tutor. Nia had completed most of the work required to attain the certificate. Nia would let the regulating officer know the timescale relating to her obtaining her certificate. Should the timescale prove unacceptable to NRW then the role will need to be covered until Nia is qualified.

As this was the first visit no breaches were recorded but advice and guidance provided to ensure compliance with the permit.
