A routine office-based visit took place on Wednesday 2nd May 2018. Present were Julie Hughes the Regulating Officer, Gwilym Director of compliance and regulation and Gareth the Operations Manager of GEWS.

The TCM had recently left the Company however, agreement had been reached that Nia would continue in the role of TCM, attending the site at least one day a week to comply with Permit. A copy of 'How to comply with your environmental permit' with reference to the relevant page regarding site attendance was sent to Nia via email.

A copy of Nia Jones' WAMITAB certificate number 16268/MROC12/1 issued on 18/12/17 was obtained. The certificate covered Level 4 Medium Risk Operator Competence for Non-Hazardous waste transfer.

Before attending site, a check had been carried out on the site's waste returns. A query arose regarding waste leaving the site as EWC code 17 05 04 and being described as wet well waste. The receiving site, Environmental Landfill Facilities Limited, based in Preston were receiving the waste and issuing transfer notes describing the waste as silt on EWC 20 03 03.

It should be noted that road sweepings accepted as 20 03 03 when de-watered do not change waste code and will remain as 20 03 03 when leaving the site. Guidance notes, previously issued to the local authority regarding road sweepings and gully waste, was left for the operator as guidance.

Please be advised that misclassification of waste is an offence under s34 of the Environmental Protection Act 1990 However on this occasion no further action will be taken as advice and guidance has been provided.
