We were accompanied around the site by Shaun MacKay.

General

Site was generally tidy and well managed. There was good segregation of waste types and waste storage was as permitted.

Evidence could be seen that a small amount of waste had been 'treated' on the pad outside of the building. This has been recorded as a Category 3 breach. Your permit states (Condition 2.3.1) 'that unless stored or treated outside as a specified waste (specified wastes are defined in 4.4. of your permit): 'all bulking, transfer or treatment of waste shall be carried out inside a building.' This issue was also highlighted during a previous inspection, the situation needs to be rectified and the waste has to be managed in accordance with your permit. You will need to consider your options to prevent this from happening again e.g. Change in working practice, change in infrastructure or change in permit.

Drainage

The settlement pond was visually observed at it was free from oil.

Fire Prevention and Mitigation Plan (FPMP)

Following the site visit the TCM for the site (Phil Rees) submitted by email a copy of the FPMP.

Duty of Care

Shaun MacKay made a query regarding some advice and guidance I made on my previous CAR form. It regarded wastes possibly being wrongly coded. Some of the wastes leaving the site were coded as a 20 code, 20 is for Municipal waste. Any waste that has been through your treatment process (sorting, etc...) should be coded with the 19 code which is for 'materials from waste or water treatment'. This was not been recorded as a breach of permit however, you were reminded that as part of your Duty of Care you must ensure that you are correctly classifying waste that you receive and remove from site.
