During my visit I was accompanied around the site by Les Davies site Foreman.

Whilst no non-compliances were noted there were a few observations I would like to raise:

The site was considerably busier than my previous visit and there were some housekeeping issues. Several of the storage bays (particularly the scrap metal) were near their capacity, this could lead to a loss of segregation of the waste types.

The photograph below shows the issue:



When time allows operators should be advised to ensure that different waste types are confined back to their nominated bays.

EMS

Following the visit, upon request David MacKay (named TCM for site) submitted an updated copy of the EMS for the site dated January 2015. This EMS was not inspected in detail during this inspection but will be audited at a future date.
