General observations:

Site was busy but well managed, no non compliances were observed during the visit.

Waste was segregated and stored as per the permit conditions with notable reduction in the quantity of scrap kept on site since previous visit.

TCM:

David MacKay is the Certificate of Technical Competence holder for the site. The current period of continued competence expires in February 2018. Steven Thomas and Les Davies are still working towards WAMITAB qualification.

EMS:

The EMS was not reviewed under this inspection.

Other:

Duty of Care paperwork for off site disposal of effluent from the sealed drainage system was inspected and the wrong EWC code has been used. **This has been recorded as a category 4 breach.** This issue has been discussed with the TOTC for the site David Mackay and processes will be amended to ensure correct EWC codes are used.
