2014 and 2015 Waste Return Review

A review of the waste returns for permit number EPR – BP3691ET has been completed.

The following issues were identified:

- EWC code 130208 (other engine, gear and lubricating oils) has been miss-consigned on the 2014 and quarter 4 2015 waste returns. This waste code is not permitted by the site permit. Amended returns have been resubmitted to NRW.
- EWC code 170605 (construction materials containing asbestos) has been included on the 2014 and quarter 4 2015 waste returns. A tonnage of '0' has been noted against each entry under this code on the waste returns. This EWC code is not permitted by the site permit. If a waste code tonnage is '0' then an entry should not be recorded on any waste return submitted to NRW. Amended returns have been resubmitted to NRW.
- A CCS Category 4 breach has been recorded for failing to complete the waste returns correctly.

Summary of breaches noted upon this review:
