4. Details of our assessment

Emissions Monitoring for Q4 (01/10/21 to 31/12/2021) and 2021 Annual Reporting

Requirements - Permit Condition 3.3.1 requires the operator to undertake monitoring as specified in tables S3.1, S3.2 and S3.3 of Schedule 3(b) of the permit. The results of that monitoring are required to be reported to Natural Resources Wales in accordance with Schedule 4(b) and table S4.1. Furthermore, Permit Condition 4.2.2 requires annual reporting of performance parameters.

Findings - Annual performance parameters and Q4 monitoring returns for emission points W2 (to water) and A6 and A15 (to air) were received on 28/01/2022. Most monitored emissions were as required by the permit and within the relevant emission limit values.

Permit Condition 3.3.1 requires the monitoring detailed in Schedule 3(b), Table S3.3. This table implements annual limits for several substances including Chemical Oxygen Demand (COD) at a limit of 4.0 kg/t. The annual limit for COD has not been reported. All other substances required to be reported by Table S3.3 were reported on the Water 1 form. Although the Water 1 form does contain an entry for COD this record is for the spot sampling required by Table S3.2.

Score - the omission in reporting raises a CCS Score 4 in relation to Permit Condition 3.3.1 requires the monitoring detailed in Schedule 3(b), Table S3.3.

Action - Submit the annual quantity for COD in kg/t.

Permit Condition 4.2.2(a) requires *a review of the results of the monitoring and assessment carried out in accordance with the permit including an interpretive review of that data*. Only data was received from the operator. The operator should for the next submission review and comment upon data trends (quarterly and yearly) highlighting and issues with monitoring, and improvements or deterioration in recorded emissions. For example, the Priority Hazardous Substance C10-13 Chlorohexanes has not been reported on in the annual submission. Details of this omission and attempts made to secure suitable testing could be outlined in future annual reports.

Action: interpretation and review of gathered data should be conducted and submitted in the next annual report.
