4. Details of our assessment

Review of monitoring returns

Condition 3.3.1 requires the operator to undertake point source emissions monitoring as detailed in Table S3.1. Annual emissions monitoring was undertaken on 01 December 2021 and the results received on 27 January 2022. The results are compliant with Condition 3.1.2 and emission limits were not exceeded.

Annual performance reporting

Condition 4.2.2 of the permit requires a report on the performance of the permitted activities over the previous year to be submitted. This was received on the 27 January 2022.

Production tonnage at the facility increased during 2021. Energy and water consumption also increased but the MWh and m3 per unit output remained consistent.
