A review of the quarters 1, 2, 3, 4 2015 and quarters 1, 2 2016 waste return submissions for permit number EPR-TP3999VA has been completed. Condition 4.2.2 of your environmental permit requires you to submit your waste returns within one month of the end of each quarter. Unfortunately we have not received the waste returns for quarters 1 and 2 2016. As a direct result of this breach of your permit condition a CCS score 4 has been applied.

Action - Please ensure that the missing returns for quarter 1 and quarter 2 2016 are submitted to waste.returns@cyfoethnaturiolcymru.gov.uk no later than 3rd October 2016. Also ensure that a system is put in place by the 3rd October 2016 to prevent this breach of your permit occurring again in the future.

Can I remind you that the returns for quarter 3 2016 are due to be submitted to Natural Resources Wales no later than the 31st October 2016. I have attached a copy of the waste return template for your use. Please remember to enter your permit number EPR-TP3999VA and not your EAWML on the form and in box 2.2 you need to enter is A11: Household, Commercial & Industrial Waste Transfer Station.
